## **AUTHORIZATION**

With respect to all repair work, which may be performed by Monroe Tractor on any, some, or all of the Purchaser's machinery and/or equipment at any future time, or times, the following shall apply:

- 1. The Purchaser hereby authorizes Monroe Tractor to perform repairs on the Purchaser's machinery and/or equipment, without Monroe Tractor being required to obtain any signature by, or on behalf of, the Purchaser on Monroe's Work Order, or any other document with respect to repairs.
- All parts and materials shall be covered by manufacturers' warranties, if any.
  WHETHER OR NOT COVERED BY MANUFACTURERS' WARRANTIES,
  MONROE TRACTOR MAKES NO WARRANTIES, EXPRESS OR IMPLIED,
  OR OF MERCHANT ABILITY OR FITNESS FOR A PARTICULAR PURPOSE.
- 3. If any workmanship performed by Monroe Tractor is defective, Monroe Tractor's sole obligation shall be to correct such defective workmanship. Under no circumstances shall Monroe Tractor be responsible for any other failures, including, without limitation, those which are the result of the Purchaser's abuse, negligence and/or lack of proper maintenance.
- 4. Under no circumstances shall Monroe Tractor be responsible for "downtime" expenses, cargo damage, or any business costs or losses resulting from defects in material or workmanship. MONROE TRACTOR SHALL NOT BE RESPONSIBLE FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES.
- 5. Monroe Tractor shall not be held responsible for loss or damage to the machinery or equipment or articles left in the machinery or equipment in the case of fire, theft, or any cause beyond Monroe Tractor's control, or any delays caused by unavailability of parts or delays in parts shipment by the supplier or transporter.
- 6. The Purchaser grants Monroe Tractor, and its employees, permission to operate such machinery and equipment on streets, highways, and elsewhere. for the purpose of testing and/or inspection.
- 7. The Purchaser agrees to pay cash for parts, materials and labor, with respect to such future repairs or on terms satisfactory to Monroe Tractor, and until paid in full, Monroe Tractor shall have a lien on the machinery and/or equipment to which the repairs were made for the unpaid balance.
- 8. This Authorization shall remain in effect, until cancelled, in writing, by the Purchaser, and sent by Certified Mail/Return Receipt, to Monroe Tractor. Such cancellation shall have no effect on repairs then in process.
